Order dated 6/2/06 [322] is amended as follows: Jury trial held. Jury deliberation began. Jury returns its verdict in favor of plaintiff and against defendants. Jury awards \$700,000.00 in compensatory damages against defendants and \$1,000,000.00 in punitive damages against defendant Donald Dreesbach and defendant John Gorman.
